ORDER:

In the reference 2 nd read above, orders were issued for constituting State Level Vigilance Committee under the Chairmanship of Hon'ble Minister for Price Monitoring, Consumer Affairs, Food and Civil Supplies, Legal metrology with the composition of Official & Non official members as mentioned in the Annexure therein.

4. The Member Convener, State Level Vigilance Committee shall take further necessary action to convene the State Level Vigilance Committee meeting as per the orders issued in the G.O.read above and to follow the guidelines issued therein.
