ORDER:

Orders were issued in Andhra Pradesh Food Security Rule 2017, to monitor the implementation of the National Food Security Act, 2013 in the State. According to Rule 9, of A.P.F.S. Rules 2017, Vigilance Committees shall be constituted to perform the functions as prescribed under Section 29 of the NFS Act, 2013 and to change the nomenclature of the Food Advisory Committees as Vigilance Committees

2. In the reference read above, orders were issued reconstituting the Vigilance Committees at various levels i.e., at State, District, Mandal and Fair Price Shop levels, keeping in view the guidelines issued under the National Food Security Act, 2013, Targeted Public Distribution System (Control) Order, 2015, the Andhra Pradesh Food Security Rules 2017 issued under the NFS Act, 2013 .

3. During the State Level Vigilance Committee Meeting held on 10.04.2018, some of the members have raised issues related to formers and Agriculture sector. Further, during the meeting held on 12.04.2018, the representatives of A.P. State Rice Millers Association have stated that representation was not provided in Vigilance Committee to the Rice Millers.

4. After careful examination of the matter, Government have decided to provide representation to Rice Millers Association at State level and District level Vigilance Committees and to farmers at Fair Price Shop (Rural) level Vigilance Committees. Government hereby issued the following amendments to the G.O. issued in the read above :

(i) at State level Vigilance Committee, after Sl.No."g", the following shall be added :

g) (i) State President, A.P. State Rice Millers Association – Member.

- (ii) at District level Vigilance Committee, after Sl.No. "p", the following shall be added :

p) (i) District President, District Rice Millers Association – Member

- (iv) at Fair Price Shop (Rural) Level Vigilance Committee , after Sl.No.12 the following shall be added :

13) One farmer nominated by Gram Panchayat – Member

The Other conditions indicated in the G.O. cited, shall be followed scrupulously.
