Sealed tenders / quotations are invited from agencies / companies towards supply of Thermal Paper Rolls. The Schedule of Requirement is as follows:

1.	Nature of work	=	Supply of Thermal Paper Roll to electronic Point of Sale Devices installed at Fair Price Shops in the districts in the State. Requirement for 20,810 F.P. Shops.

2.	Visual inspection	=	Check for damages and packing quality
3.	Approved supplier	=	As per approved supplier list
4.	Physical Dimension(d x L)	=	41.40 x 56.0 +1.0 mm
5.	Paper thickness	=	0.06 mm +/- 0.01 mm
6.	Bobbin inner dia	=	12.5 mm
7.	Bobbin outer dia	=	14.90 mm
8.	Room temp	=	25 deg C +3 degC
9.	Paper length	=	20 mtrs

10. The cover containing quotation should be sealed and superscribed "Tender for supply of Thermal Paper Rolls" and submit to the address "The Commissioner of Civil Supplies, Andhra Pradesh State, IV Floor, Block-A, Civil Supplies Bhavan, Opp: Errammanzil, Hyderabad-082".

11. The tender can be posted by hand in the Tender Box kept in the Office of the Commissioner of Civil Supplies, Andhra Pradesh State, IV Floor, Block-A, Civil Supplies Bhavan, Opp: Errammanzil, Hyderabad-082 not later than 3.00 p.m. on 27 -07--2015.

12. The tender will be opened by the officer authorized for the purpose on 27-07-2015 at 5.00 p.m. in the Chambers of Deputy Director, IT Wing, IV Floor, Block-A, C.S. Bhavan, Opp: Errammanzil, Hyderabad in the presence of tenderers at 5.00 p.m. on the same date.

13. The Tenderers will be required to make a presentation of specifications, design of the Thermal Paper Roll after opening of tenders.

14. The Tender will be valid for 30 days from the date of opening of tender and there should be clear mention in the Tender to that effect.
15. It is the responsibility of the tenderers to see that their tenders reach the Office of the Commissioner of Civil Supplies, Andhra Pradesh State, IV Floor, Block-A, Civil Supplies Bhavan, Opp: Errammanzil, Hyderabad-082 by due date and time. The fact of having posted a quotation in time and delayed in post or mislaid / misdirected due to incomplete or incorrect superscription or other causes, this office will not be held responsible.
16. Any correction of error on the quotation should be duly authenticated by the person signing the quotation. Over writing should be avoided.
17. The Office of the Commissioner of Civil Supplies, AP., Hyderabad reserves the right to accept or reject any tender or all the tenders without assigning any reason to the Tenderer.
18. The contract period is initially for a period of one year on successful supply of thermal paper roll by the vendor as per the approved specifications, design, etc., and will be extended from year to year based on the requirement.
19. The successful tenderer is to submit PERFORMANCE SECURITY DEPOSIT amounting to 1% of the total value of work shall be deposited as Security Deposit by way of Bank Guarantee within a day from the date of receipt of supply order which will be continued till contract exists with the vendor, for due fulfillment of the contract which will be refunded after completion of contract period.
20. Any kind of canvassing in regard to the offered supply of thermal paper roll after submitting Tender will be treated as disqualification.
21. In case of any public holiday or any eventualities like Bundh, Strike, Natural Calamities, etc., the tender will be opened on following working day of the date of opening of tender prescribed in the tender schedule.

The supply agencies are requested to submit their quotation towards supply of Thermal Paper Rolls. The invitation to tender is subject to fulfillment of above mentioned instructions and conditions.
